**SCHOOL BOND ELECTION
KEARNEY COUNTY SCHOOL DISTRICT 0501
(AXTELL COMMUNITY SCHOOLS)
IN THE STATE OF NEBRASKA**

"Shall Kearney County School District 0501 (Axtell Community Schools) in the State of Nebraska issue its bonds in a total principal amount not to exceed \$5,495,000 for the purposes of financing the costs of (a) constructing an addition to and renovations of the District's existing K-12 building and related site improvements, and (b) purchasing certain equipment, furniture and apparatus for such building and addition; said bonds to be issued from time to time, to be sold at such prices, to bear interest at such rates, to become due at such times, and to have such other terms and provisions, all as may be fixed and determined by the Board of Education of the District; and

"Shall the District cause to be levied and collected annually a special levy of taxes against all the taxable property in the District sufficient in rate and amount to pay the principal of, the premium, if any, and the interest on said bonds as the same become due?"

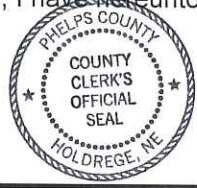
FOR said bonds and tax AGAINST said bonds and tax

Qualified electors voting in favor of said proposition shall blacken the oval opposite the words "FOR said bonds and tax" following said proposition, and qualified electors voting against said proposition shall blacken the oval opposite the words "AGAINST said bonds and tax" following said proposition.

Proposed Constitutional Amendments, title and text will be published by the Secretary of State once each week for 3 consecutive weeks preceeding the Primary election. The publication will be a true copy of the title and text of each measure to be submitted.
