

NOTICE OF SPECIAL BOND ELECTION
PHELPS COUNTY SCHOOL DISTRICT 55
(LOOMIS PUBLIC SCHOOLS)
IN THE STATE OF NEBRASKA
TUESDAY, OCTOBER 14, 2025

Public notice is hereby given to the qualified electors of Phelps County School District 0055 (Loomis Public Schools) in the State of Nebraska (the "District") that at a special election to be held in said District on Tuesday, October 14, 2025, there shall be submitted to the qualified electors of the District the following proposition:

"Shall Phelps County School District 0055 (Loomis Public Schools) in the State of Nebraska issue its bonds in a total principal amount not to exceed \$18,250,000 for the purposes of financing the costs of (i) constructing certain additions to and renovations of its existing school building and related site improvements, and (ii) purchasing the necessary equipment and apparatus related to such improvements; said bonds to be issued from time to time, to be sold at such prices, to bear interest at such rates, to become due at such times, and to have such other terms and provisions, all as may be fixed and determined by the Board of Education of the District; and

"Shall the District cause to be levied and collected annually a special levy of taxes against all the taxable property in the District sufficient in rate and amount to pay the principal of, the premium, if any, and the interest on said bonds as the same become due?"

Qualified electors voting in favor of said proposition shall blacken the oval opposite the words "FOR said bonds and tax" following said proposition, and qualified electors voting against said proposition shall blacken the oval opposite the words "AGAINST said bonds and tax" following said proposition.

Election by Mail: This election will be an election by mail. Each active registered voter residing within the District will receive a ballot by mail at his/her address as it appears on the voter registration register; and therefore no polling places will be open for voting. Ballots will be mailed by the Phelps County Clerk's Office, and the Harlan County Clerk's Office between September 22, 2025 and October 3, 2025.

Voter Registration Deadlines:

- 1. September 26, 2025: is the last day for mail-in registrations, registrar registrations, delivered registrations, agency registrations and online registrations (3rd Friday prior to the election)
- 2. October 3, 2025: is the last day for in-person voter registration in the office of the Phelps County Clerk or Harlan County Clerk. (6:00p.m.)

Early Voting Ballot: Voters may complete an "Application for Early Voting Ballot" available from the office of the Phelps County Clerk or Harlan County Clerk. The last day to request an Early Voting ballot to be mailed: Friday, October 3, 2025 at 6:00 p.m. Early voting requests made after ballots have been mailed require an affidavit to be completed with their request. Contact the Phelps County Clerk or Harlan County Clerk with questions.

Ballot Return Deadline: Voted ballots that are sealed in the "Return Identification Envelope" may be returned in person, by deposit in the ballot drop box or mailed to the Phelps County Clerk or Harlan County Clerk offices.

NOTE: All ballots must be in the possession of the Phelps County Clerk or Harlan County Clerk no later than 5pm on Election Day, October 14, 2025.
