Notice is also given that the filing deadlines for such offices are February 17, 2026, at 5:00 o’clock p.m. for incumbents and March 2, 2026, at 5:00 o’clock p.m. for non-incumbents. An incumbent is anyone serving in an elective office, even if they are filing for an office other than the one in which they are presently serving, they are required to file by 5:00 o’clock p.m. on February 17, 2026.
