The Phelps County Board of Commissioners met in regular session on August 20, 2024, as advertised, with Commissioners Dennis Ostgren; Russ Cruise; Tom Nutt; Matt Gregg; Rick Streeter and Theresa Puls present. Barb Malm absent. The meeting was called to order by Chairman Puls. The Pledge of Allegiance was recited. Theresa announced the open meeting law would be in effect and that a copy is posted on the wall. Ostgren moved, seconded by Cruise, to approve the minutes of the previous meeting. Roll call vote was Nutt, yes; Cruise, yes; Gregg, yes; Streeter, yes; Ostgren, yes; Puls, yes. Malm absent. Motion carried.

At 9:01 a.m. the Board went into session as a Board of Equalization. Natalie Nesen -Pacey, County Attorney, Amber Imler, Deputy County Assessor and Sally Fox, County Clerk and Patti Meguire, County Treasurer were present. Barb Malm absent.

Amber presented the cemetery list to the Board and after discussion Cruise moved, seconded by Streeter, to approve the cemetery list. Roll call vote was Nutt, yes; Cruise, yes; Gregg, yes; Streeter, yes; Ostgren, yes; Puls, yes. Malm absent. Motion carried.

The Board discussed a letter they received from the state on 2 permissive exemptions they approved in July from Adjacent Air, LLC and Lighthouse Baptist Church. They said these permissive exemptions were filed after the December 31, 2023, deadline and were approved without the required waiver by the Board to allow the County Assessor to consider the exemption application per statute 77-202.01(2). They suggested the Board should deny these exemptions and since applications were late Adjacent Air had a fee of \$510 and Lighthouse Baptist Church has a late fee of \$593. After discussion Cruise moved, seconded by Nutt, to reaffirm our approval of the Adjacent Air, LLC permissive exemption. Patti Meguire, County Treasurer, reviewed motor vehicle exemptions from Christian Homes a 2006 Chevy Pickup: SCEDD, 2023 Ford Sport Utility and from Vetter Home Health Card of Central NE a 2018 Toyota Sedan. After discussion Streeter moved, seconded by Ostgren, to approve the motor vehicle exemptions presented by Patti. The Board resumed its regular session as a Board of Commissioners at 9:30 a.m.

Amber Imler, Deputy Assessor, presented to the Board the certification of taxable value and value to attributable growth. The total value of Phelps County is \$2,828,081,049 with \$28,597,908 attributable growth.

Robin Hinrichs a candidate running for NPPD District 6 met with the Commissioners to introduce himself.

Justin Norris, met with the Board with projects to the courthouse for this fiscal year. The projects Justin discussed were remodeling offices for the District Judge, court and jury room and judge chambers, repairing the elevator, new courthouse door entry system, repair the concrete around the parking lot and sidewalk, snow melt piping for entry by the jail and repairing the road building. The Board gave Justin approval to go forward with the projects.

Bobby Hamilton, Highway Supt., met with the Board with his road report. Nutt moved, seconded by Ostgren, to approve the request from Bobby to transfer 63.46 hours from the sick leave bank for Andrew Richards.
