## COMMISSIONERS ROOM, HOLDREGE, NE 9:00 A.M November 19, 2024

The Phelps County Board of Commissioners met in regular session on November 19, 2024, at 9:00 A.M. as per public notice given in the Holdrege Daily Citizen on November 12, 2024, a copy of the proof of publication being on file in the County Clerk's Office. Availability of the agendas was communicated in the advance notice of the meeting. All of the proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Commissioners Dennis Ostgren; Russ Cruise; Tom Nutt; Barb Malm; Matt Gregg and Theresa Puls present. Rick Streeter was absent. The meeting was called to order by Chairman Puls. The Pledge of Allegiance was recited. Theresa announced the open meeting law would be in effect and that a copy is posted on the wall. Ostgren moved, seconded by Malm, to approve the minutes of the previous meeting. Roll call vote was Malm, yes; Cruise, yes; Gregg, yes; Nutt, yes; Ostgren, yes; Puls, yes. Streeter absent. Motion carried.

At 9:00 a.m. the Board went into session as a Board of Equalization, Rick Streeter was absent. Larissa Davenport, County Assessor, Sally Fox, County Clerk and Natalie Nelsen-Pacey, County Attorney were present. Larissa reviewed tax list correction # 51 with the Board. Bobby Hamilton, Highway Supt., met with the Board with his road report. Bobby talked about the skid steer loader lease renewal agreement with Landmark Implement on a 2024 333P loader. This is a 1-year lease in the amount of \$5,000 per year up to 100 hours of use. After discussion Ostgren moved, seconded by Cruise, to approve the lease renewal with Landmark Implement.
