The Phelps County Board of Commissioners met in regular session on February 25, 2025, at 9:00 A.M. as per public notice given in the Holdrege Daily Citizen on February 18, 2025, a copy of the proof of publication being on file in the County Clerk's Office. Availability of the agendas was communicated in the advance notice of the meeting. All of the proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Commissioners Matt Gregg; Russ Cruise; Rick Streeter; Tom Nutt; Barb Malm and Dennis Ostgren were present. Theresa Puls was absent. The meeting was called to order by Chairman Ostgren. The Pledge of Allegiance was recited. Dennis announced the open meeting law would be in effect and that a copy is posted on the wall. Malm moved, seconded by Cruise, to approve the minutes of the previous meeting. Roll call vote was Malm, yes; Cruise, yes; Nutt, yes; Streeter, yes; Gregg, yes; Ostgren, yes. Puls absent. Motion carried.
