## COMMISSIONERS ROOM, HOLDREGE, NE 9:00 A.M. June 17, 2025, 2025

The Phelps County Board of Commissioners met in regular session on June 17, 2025, at 9:00 A.M. as per public notice given in the Holdrege Daily Citizen on June 10, 2025, a copy of the proof of publication being on file in the County Clerk's Office. Availability of the agendas was communicated in the advance notice of the meeting. All of the proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Commissioners Tom Nutt; Matt Gregg; Barb Malm; Theresa Puls; Russ Cruise and Dennis Ostgren were present. Rick Streeter was absent. The meeting was called to order by Chairman Ostgren. The Pledge of Allegiance was recited. Dennis announced the open meeting law would be in effect and that a copy is posted on the wall. Nutt moved, seconded by Cruise, to approve the minutes of the previous meeting. Roll call vote was Nutt, yes; Gregg, yes; Cruise, yes; Malm, yes; Puls, yes; Ostgren, yes. Streeter absent. Motion carried.

At 9:00 a.m. the Board went into session as a Board of Equalization, Larissa Davenport, County Assessor, Sally Fox, County Clerk and Corey O'Brien, County Attorney, were present.

Protest #11, parcel 3288, Jason Anderson with South Central Feeder met with the board to protest the increase of their valuation. Larissa recommended adjusting the property to \$4,287,206. Puls moved, seconded by Cruise, to reduce the value based on the Assessor's recommendation. Roll call vote was Nutt, yes; Cruise, yes; Gregg, yes; Puls, yes; Malm, yes; Ostgren, yes. Streeter absent. Motion carried.

Protest #1, parcel 4430.1, David Winkler was discussed. Larissa recommended adjusting the property to \$332,840. Malm moved, seconded by Puls, to reduce the value based on the Assessor's recommendation. Roll call vote was Nutt, yes; Cruise, yes; Gregg, yes; Puls, yes; Malm, yes; Ostgren, yes. Streeter absent. Motion carried.

Protest #2, parcel 5206, Keith Fagot was discussed. Larissa recommended adjusting the property to \$235,816. Cruise moved, seconded by Nutt, to reduce the value based on the Assessor's recommendation. Roll call vote was Nutt, yes; Cruise, yes; Gregg, yes; Puls, yes; Malm, yes; Ostgren, yes. Streeter absent. Motion carried.

Protest #3, parcel 191, Amanda Williams was discussed. Larissa recommended adjusting the property to \$303,505. Cruise moved, seconded by Malm, to reduce the value based on the Assessor's recommendation. Roll call vote was Nutt, yes; Cruise, yes; Puls, yes; Gregg, yes; Malm, yes; Ostgren, yes. Streeter absent. Motion carried.

Protest #4, parcel 6628, Byron Anderson was discussed. Larissa recommended adjusting the property to \$363,963. Puls moved, seconded by Nutt, to reduce the value based on the Assessor's recommendation. Roll call vote was Nutt, yes; Cruise, yes; Puls, yes; Gregg, yes; Malm, yes; Ostgren, yes. Streeter absent. Motion carried.

Protest #5, parcel 5402.1, Shawna Nelson was discussed. Larissa recommended adjusting the property to \$551,915. Malm moved, seconded by Cruise, to reduce the value based on the Assessor's recommendation. Roll call vote was Nutt, yes; Cruise, yes; Puls, yes; Gregg, yes; Malm, yes; Ostgren, yes. Streeter absent. Motion carried.

Protest #6, parcel 7479.11, Dell Pearson was discussed. Larissa recommended no change. Nutt moved, seconded by Gregg, to approve no change based on the Assessor's recommendation. Roll call vote was Nutt, yes; Cruise, yes; Gregg, yes; Puls, yes; Malm, yes; Ostgren, yes. Streeter absent. Motion carried.

Protest #7, parcel 6416, Sheryl Olson, was discussed. Larissa recommended adjusting the property to \$334,170. Malm moved, seconded by Puls, to reduce the value based on the Assessor's recommendation. Roll call vote was Nutt, yes; Cruise, yes; Gregg, yes; Puls, yes; Malm, yes; Ostgren, no. Streeter absent. Motion carried.

The Board resumed its regular session as a Board of Commissioners at 9:29 a.m.

At 9:30 a.m. as advertised, the board received gravel bids from Broadfoot & Sons Sand & Gravel, Southwest Sand & Gravel, Mid Nebraska Aggregate, Paulsen Inc. and Overton Sand & Gravel. The bids were for location 1-5 and the loaded pit price. Bobby will review the bids with the road committee and give his recommendation next week. Gravel bids are for the fiscal year starting July 1, 2025 and ending June 30, 2026.

Lori Larson, Bill Yochum and Sierra Burrows, representing the library gave an annual report and submitted their proposed budget for the county portion of this coming year in the amount of \$152,500.

Bobby Hamilton, Highway Supt., met with the board with his road report. Bobby told the board they received \$17,488.52 from FEMA for repair work performed after the 2019 flood.

Nutt moved, seconded by Malm, to approve the vendor claims for the month of June. Roll call vote was Nutt, yes; Gregg, yes; Cruise, yes; Malm, yes; Puls, yes; Ostgren, yes. Streeter absent. Motion carried.
