## COMMISSIONERS ROOM, HOLDREGE, NE 9:00 A.M. July 15, 2025

The Phelps County Board of Commissioners met in regular session on July 15, 2025, at 9:00 A.M. as per public notice given in the Holdrege Daily Citizen on July 8, 2025, a copy of the proof of publication being on file in the County Clerk's Office. Availability of the agendas was communicated in the advance notice of the meeting. All of the proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Commissioners Tom Nutt; Rick Streeter; Matt Gregg; Barb Malm; Theresa Puls; and Dennis Ostgren were present. Russ Cruise was absent. The meeting was called to order by Chairman Ostgren. The Pledge of Allegiance was recited. Dennis announced the open meeting law would be in effect and that a copy is posted on the wall. Streeter moved, seconded by Malm, to approve the minutes of the previous meeting. Roll call vote was Nutt, yes; Gregg, yes; Streeter, yes; Malm, yes; Puls, yes; Ostgren, yes. Cruise absent. Motion carried.

At 9:02 a.m. the Board went into session as a Board of Equalization. Russ Cruise was absent. Larissa Davenport, County Assessor, Sally Fox, County Clerk and Corey O'Brien, County Attorney, were present.

Protest #56, parcel 458, Briah Leahy met with the board to protest the increase of his valuation. Larissa recommended adjusting the property to \$221,270. Protest #8, parcel 3158, Jenna Roberts was discussed. Larissa recommended adjusting the property to \$536,659.
